The following tables contain updated data of California building permit activity reported by the California Homebuilding Foundation (CHF) and Construction Industry Research Board (CIRB) from January to June of 2014.

Each month, CHF|CIRB distributes the California Construction Review (CCR), a statewide permit summary for residential and non-residential construction activity. CHF|CIRB strives to receive one hundred percent of building activity reporting from all of California's municipalities on a timely basis.

Variations in permit totals and valuations from previously released 2014 California Construction Review reports are a result of post-reported county or city activity and/or post-adjusted data submitted to CHF|CIRB by the reporting municipality. We are providing this semi-annual report to reflect the most accurate, up-to-date building permit statistics for the first half of 2014.

Building Classifications Notes and Definitions

Building permit data is compiled from building permits issued by cities and counties. The building classifications used in grouping the building permit data of the preceding tables are as follows:

Residential:

Single-Family housing units include detached, semi-detached, row house and town house units. Row houses and town houses are included when each unit is separated from the adjacent unit by an unbroken ground-to-roof party or fire wall. Condominiums are included when they are of zero-lot-line or zero-property-line construction; when units are separated by an air space; or, when units are separated by an unbroken ground-to-roof party or fire wall. Corresponding valuation totals are included in the New Single Family Valuation category.

Multi-family housing includes duplexes, 3-4 unit structures and apartment-type structures with five units or more. Each type of housing is included in this report with its corresponding valuation. Multi-family also includes condominium units in structures of more than one living unit that do not meet the above single-family housing definition. Corresponding valuation totals are included in the New Multi Family Valuation category.

Residential Alterations and Additions include alterations, additions and conversions to existing residential structures. (Excludes special installation permits for electrical, plumbing, heating, air-conditioning or similar mechanical work, installation of fire escapes, fire sprinklers, elevators, signs, etc.).

Total Residential includes a sum of total construction valuations from the categories: New Single Family Valuation, New Multi Family Valuation and Residential Alterations and Additions combined.

Non-residential:

New Commercial includes new hotels and motels, office and bank buildings, stores and other mercantile buildings, parking garages, service stations, and amusement and recreational buildings.

New Industrial includes manufacturing plants and affiliated buildings.

Other New Nonresidential includes churches and religious buildings, medical and institutional buildings, school and educational buildings, agricultural buildings, and miscellaneous nonresidential structures. Hospital construction permits issued by the California Office of Statewide Health Planning are not included in the private nonresidential building data contained in this report except where the project may also be permitted by the local jurisdiction.

Nonresidential Alterations includes alterations, additions and conversions to existing nonresidential structures. (Excludes special installation permits for electrical, plumbing, heating, air-conditioning or similar mechanical work, or installation of fire escapes, fire sprinklers, elevators, signs, etc.)

Total Non-Residential includes a sum of total construction valuations from the above Non-Residential categories: New Commercial, New Industrial, Non-Residential Alterations and Additions, and New Other Non-Residential.

Total All Buildings includes a combined sum of construction valuations from all Total Residential and Total Non-Residential categories.

Photovoltaic (Solar) Installation:

Prior to 2012, Photovoltaic Installations were included in the additions and alterations categories for residential and non-residential valuations at 1/3 of the total permit valuation. Due to the increase of photovoltaic installations in California, these are now reported using full value and reported as a separate category. It should be noted that not all jurisdictions will report solar installation permits or the full valuation of the permit as a result from the state standardized fee schedule enacted in 2012.

HVAC Installations:

HVAC installations are not included in the scope of this report. If you are interested in receiving more specific information on heating and air conditioning valuation information, please contact us at CHF-CIRB@mychf.org. It should be noted that HVAC installations are sometimes not acknowledged independently from other mechanical permit valuations depending upon the reporting municipality and therefore, cannot be tracked with total accuracy.

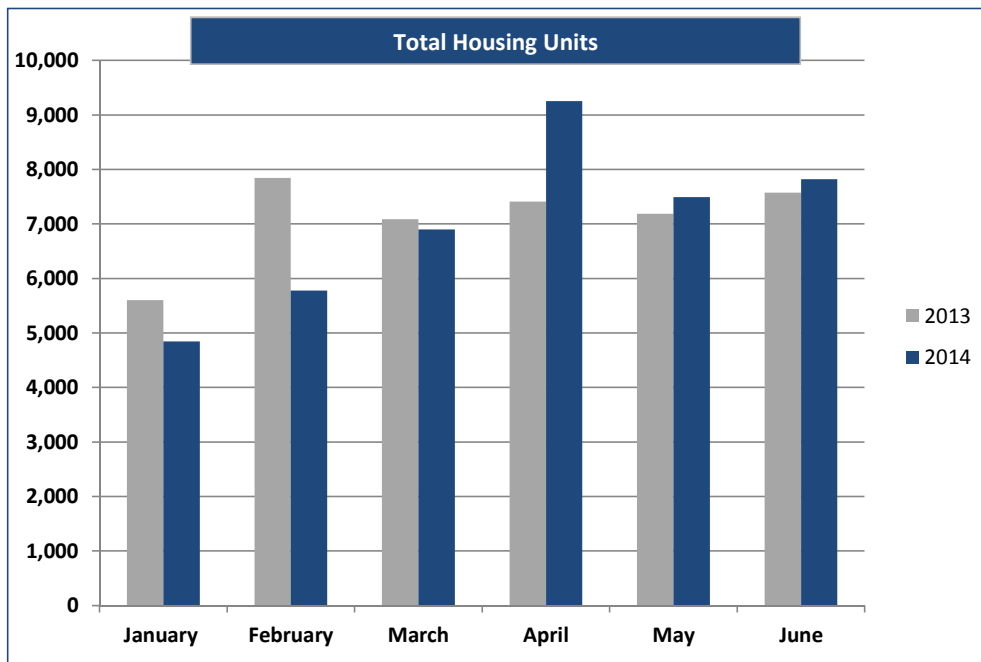

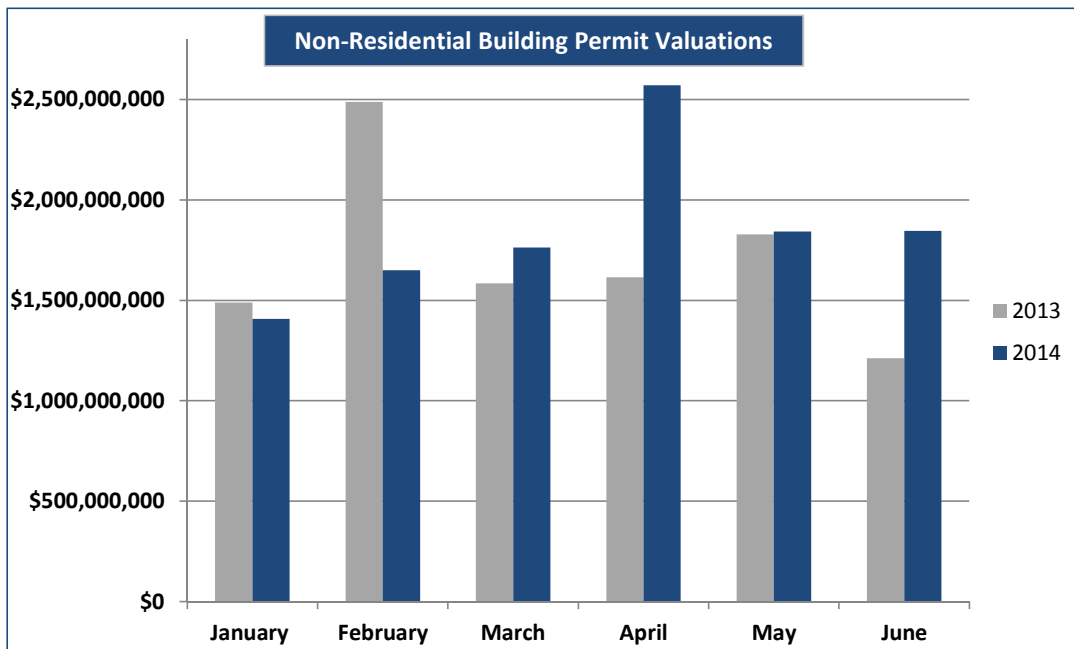
